

## OneSmart™ Activate and Load Promotion Terms and Conditions

1. Information on how to enter the promotion forms part of the conditions of entry. Entry into the promotion is deemed as acceptance of its terms and conditions.
2. To be eligible for this promotion, you must be a New Zealand resident aged 18 years or over and are a current Air New Zealand Airpoints™ member (“**Eligible Participant**”). The Promoter reserves the right to verify the validity of entries.
3. Promotion commences 01 February 2019 at 00:01 NZDT and closes 28 February 2019 at 23.59 NZDT (the “**Promotional Period**”).

### 4. **Conditions of Entry:**

How to Enter:

An Eligible Participant who:

- (a) has a current Airpoints card with OneSmart payment functionality, and during the Promotional Period:
  - (i) successfully activates their OneSmart account; and
  - (ii) loads a minimum of NZ \$100 in one load or equivalent directly into one or more foreign currencies into their OneSmart Account; or
- (b) does not have a current Airpoints card with OneSmart payment functionality, and requests a OneSmart card during the Promotional Period and subsequently successfully activates their OneSmart account and loads a minimum of NZ \$100 in one load or equivalent directly into one or more foreign currencies into their OneSmart Account by 23.59 NZDT on 11 April 2019,

Activation of your OneSmart Account will be subject to Travelex Card Services Limited, as Issuer of the OneSmart card, accepting your application, which includes successfully verifying your identity.

There are currently three ways to load money onto your OneSmart account including Bank Transfer, Bill Payment or Online instant debit load. Visit <https://www.airnzonesmart.co.nz/load-money/> and follow the online prompts.

5. Participation in the promotion is limited to one entry per person. Participants who have activated their OneSmart Account and either (a) the OneSmart Account is subsequently closed during the Promotional Period or prior to the bonus being awarded; or (b) the corresponding Airpoints Account is closed during the Promotional Period, are ineligible for the promotion.
